Bids were opened: \$2.8 million high bid, another bid of \$2.4 million, and another bid of \$1.4 million. It looks promising being this is the worst of the worst that needs done. After April 28th that part of the project will get going. The contract will be with Reynolds Brothers.

c. Mayor Mozer Discussion of continuing Economic Development Activities in the City with visits by officials of the Pennsylvania Department of Community and Economic Development, Coordinated Meetings of the Monessen Redevelopment Authority, the Monessen Planning Commission, and the Blight Property Review Board this week, in addition meetings with consultants, advisors, and potential project participants on moving ahead with plans for development in the City of Monessen.

There was a meeting with DCED (a large group was present). They were very receptive and saw that all groups were working together within the city. The DCED group see nothing but good things that they will make some opportunities available to the city. Mayor Moser mentioned the lengths that he went to to make certain everything was done correctly in relation to the demolition of 500 Donner Ave (including the pigeon problem). Also mentioned was to put together a plan as to what to do with the land once the building is demolished.

Streets and Public Improvement Report for month ending March 24, 2022

Councilman Nestor gave a report on monies collected in relation to licenses issued, permits issued and fees collected. He also reported the list provided by the Monessen Fire Chief. The Mon Valley Emergency Medical Service report was also read.

Councilman Nestor related that he spoke with the Code office on issues that need addressed. He scheduled a meeting with the Code office and selected members to go over hurdles the city is facing.

Spoke with residents on Donner Ave about private parking West of Rt. 906.

Councilman Nestor attended the Westmoreland County Dept. of Public Safety Local Emergency Coordinators Bi-Monthly meeting.

Announced there will be an emergency preparedness presentation at the Monessen Senior Center on Wednesday May 25th at 1pm.

Councilman Donald S. Gregor, Director of Parks and Public Property

Parks and Public Property Report for the month ending March 24, 2022.

Councilman Gregor had no report to give.

Councilman Gregor stated that the city building were part of his domain and there was an issue with "the bathrooms being filthy". Mayor Mozer mentioned that he is mopping the floors. Councilman Gregor spoke of getting a janitorial service. He said the men in the parks department said they need a new push mower.

Before opening the floor for public comment the mayor spoke of the search for the job position of Treasury Deputy Director and the fact that it pays \$14 an hour which is the same pay level as McDonalds.

The mayor spoke of having Cypher and Cypher come and present the 2019, 2020, and 2021 city audits.

A city resident (Donnie Retay?) spoke of advertising the availability of the pavilions in city park.

Fred Natille announced an event sponsored by the Library for the coming Sunday (noon at St. Vincent social hall). It is a lecture by Barbara Aiello on the Italians and Jews in Italy during WWII.

Ernie Telegraphis spoke of the negative projection from a city individual that appeared on a local newscast. Mayor Mozer responded that he has only been transparent.

A woman introduced herself an a new city resident. She recently purchased property in Monessen and wanted to introduce herself.

Chief of Police Yuhasz about what was discussed in the previous council meeting about the sale of the police guns. It was an oversight by council and will be addressed at the next council meeting.
